

CERTIFICATE OF SURVEY

of a parcel of land for boundary adjustment
in the SE 1/4 of Section 2,
T38N, R9E, M7M,
PARK COUNTY, MONTANA

Survey requested by Kay Rieger, personal representative of the estate of Garis Lathern, II, being her deede to create the Addition Tract as a boundary adjustment. The Addition Tract is to be added to Lot A, Park County Plat No. 364.

Scale of bearings derived from Park County Plate 25A, 329 and 871. (Centerline tangent of Burlington Northern Railroad at MP64+N1501'9). Also see my C/S's 37, 1418, and 1813. RR MP64 location determined for C/S 1418 from previous surveys before the railroad tracks were removed.



DESCRIPTION
ADDITION TRACT

A tract of land in the SE 1/4 of Section 2, T38, R9E, M7M, Park County, Montana, being a portion of Lot C, Park County Plat No. 18A (Plat 18A). This tract is to be added to Lot A, Park County Plat No. 364 (Plat 364).

From the meander corner on the south line of said Section 2, which is on the left bank of the Yellowstone River and is marked with a 1 1/2" cap, the point of beginning is N89°25.97'W a distance of 844.97 feet. The point of beginning is marked with a square 3/8 inch rod at the southwest corner of Lot A, Plat 364.

Thence N071.72°E along the westerly boundary of Lot A, Plat 364 and stang the westerly boundary of Lot C, Plat 18A a distance of 300.00 feet to a point marked with a Surv Kap.

Thence N89°48.74'W a distance of 25.00 feet to a point marked with a Surv Kap.

Thence S071.57°W a distance of 300.00 feet to a point which is witnessed by a Surv Kap which is N071.72°E a distance of 30.00 feet from the true point.

Thence S89°48.72' along the westerly boundary of Lot C, Plat 18A a distance of 25.00 feet to the point of beginning.

The above described tract contains 0.17 acres, more or less.

Subject to an easement for road and utility purposes, extending 30 feet northerly from the south boundary of this tract.

Subject to any easements of record or apparent from visual inspection.

CERTIFICATE OF EXEMPTION

The land from which the Addition Tract is created is held in single undivided ownership by Arwilda E. Weir, I, the undersigned, hereby acknowledge that this is a division of land exempted from public review as a subdivision. This survey is made "outside of partition subdivisions for purpose of relocating common boundary lines between adjoining properties", (Montana Subdivision and Platting Act, Section 76-3-207 (1)(c)). Also this division is made for the purpose of "securing additional land to become part of a parcel that does not have sanitary restrictions imposed provided that no dwellings or structures requiring water or sewage facilities will be erected on the additional acquired parcel." (Montana Subdivision and Platting Act ARM 17.36.805 2(a)).

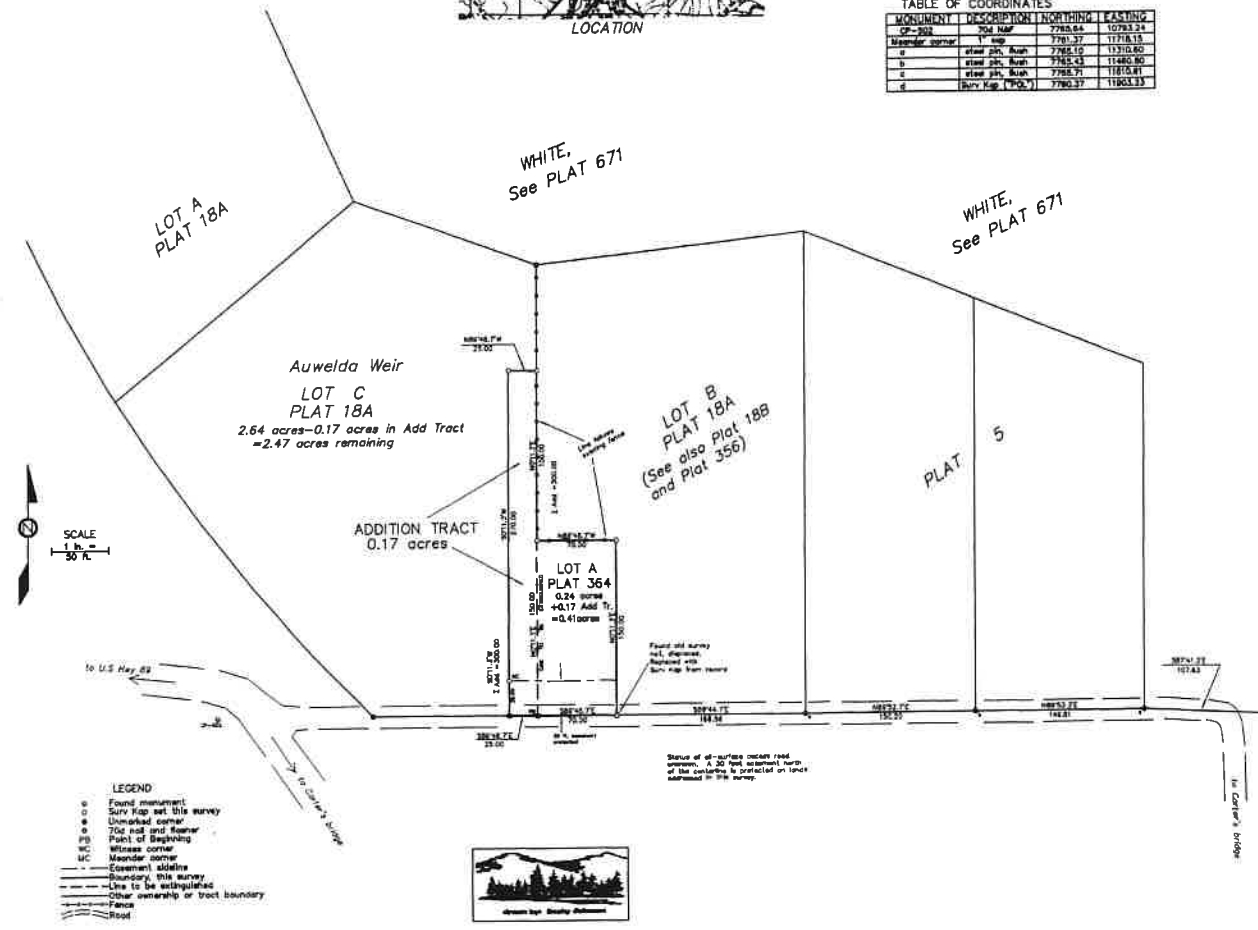
