

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

Corner Closing Cor. Sec. 5 & 6 T. 24 R. 21 P.M.M. Lake County

Record: Set a trap rock, 24 x 12 x 5 ins., 18 ins. in the ground for the closing corner of secs. 5 & 6, marked CC on S. face, with 5 grooves on E. and 1 groove on W. face, from which a pine, 10 ins. diam., bears S. 49° 30' E., 127 lks. dist., marked T24N R21W S5 CC BT. A tamarack, 14 ins. diam., bears S 42° 30' W., 83 lks. dist., marked T24N R21W S6 CC BT.

Found: Stone firmly set, with 5 nothces on E. side and 1 notch on W. side. Rocks scattered around corner. BT stump bears S. 42° 30' W, 54.78' dist., marked T24N R21W S6 CC BT. A pine bears S. 49° 30' E., 83.82' dist., scribing visible. Found 6" tamarack scribed RM., bears S. 44° W., 12.78' dist.

To perpetuate corner I tagged BT's with BIA Bearing Tree tags, and piled rocks around corner stone.
