THE STATIC WATER LEVEL AT THE PERMITTED WELL SHALL BE MEASURED MONTHLY AT MID-MONTH. THE MEASUREMENT SHALL BE MADE AT LEAST ONE (1) HOUR AFTER DIVERSION FROM THE WELL HAS BEEN DISCONTINUED. A YEARLY REPORT GIVING THE DATE, DATUM, AND DEPTH TO WATER SHALL BE SUBMITTED TO THE HELENA WATER RESOURCES REGIONAL OFFICE, PH: 406-449-0944 FAX: 406-442-9315 BY NOVEMBER 30 OF EACH YEAR, AND UPON REQUEST OF THE HELENA REGIONAL OFFICE.

WATER MEASUREMENT REQUIREMENT - UNIQUE TYPE

THIS RIGHT IS SUBJECT TO THE CONDITION THAT THE APPROPRIATOR SHALL INSTALL AN ADEQUATE FLOW METERING DEVICE IN ORDER TO ALLOW THE FLOW RATE AND VOLUME OF WATER DIVERTED TO BE RECORDED. THE APPROPRIATOR SHALL KEEP A YEARLY WRITTEN RECORD OF THE FLOW RATE AND VOLUME OF ALL THE WATERS DIVERTED INCLUDING THE PERIOD OF TIME, AND SHALL SUBMIT SAID RECORDS TO THE HELENA WATER RESOURCES REGIONAL OFFICE, PH: 406-449-0944 FAX: 406-442-9315 BY NOVEMBER 30 OF EACH YEAR, AND UPON REQUEST OF THE HELENA REGIONAL OFFICE. THE MEASURING DEVICE MAY BE INSTALLED TO MEASURE THE ENTIRE FLOW TO TOWN VIEW ESTATES SUBD.
