THE APPROPRIATOR SHALL INSTALL AN ADEQUATE WATER FLOW MEASURING DEVICE, AT A SUITABLE LOCATION AS NEAR AS PRACTICABLE TO THE POINT WHERE THE WATER IS DIVERTED FROM THE SOURCE OF SUPPLY, IN ORDER TO RECORD THE FLOW RATE AND VOLUME OF WATER DIVERTED. THE APPROPRIATOR SHALL KEEP A WRITTEN RECORD OF THE FLOW RATE AND VOLUME OF ALL WATERS DIVERTED INCLUDING THE PERIOD OF TIME AND SHALL SUBMIT SAID RECORDS TO THE DEPARTMENT UPON REQUEST.
