DURING THE EXAMINATION OF BASIN 43P, DNRC DETERMINED THAT THE ORIGINAL CODING FOR THIS RIGHT AS A RESERVED RIGHT WAS NOT CORRECT AND SHOULD BE A USE RIGHT.

AS OF 04/02/2015, THIS WATER RIGHT APPEARS TO BE OWNED BY DONALD R LEE JR, PO BOX 95, BILLINGS, MT 59103.

THE PRIORITY DATE MAY BE QUESTIONABLE. THE AFFIDAVIT STATES THE DEVELOPED SPRING WAS COMPLETED IN AUGUST 1954.

IT IS NOT CLEAR WHETHER THIS CLAIM IS A STATE-BASED WATER RIGHT OR PART OF THE TRIBAL WATER RIGHT AS DEFINED IN THE CROW TRIBE - MONTANA COMPACT. ADDITIONAL EVIDENCE MAY BE REQUIRED BEFORE THIS CLAIM CAN BE DECREED.
