PERMIT 41H-84093 HAS A FLOW RATE OF 440 GPM AND A VOLUME OF 125 ACRE-FEET. PERMIT 41H-100773 HAS A FLOW RATE OF 700 GPM AND A VOLUME OF 140 ACRE-FEET.
