1. WATER MEASUREMENT RECORDS REQUIRED, WATER MONITORING REQUIRED, AND A WATER MEASURING/MONITORING PLAN REQUIRED.

A. INSTALL A MEASURING/MONITORING DEVICE IN COTTONWOOD CREEK AT OR NEAR WHERE THE HIGHWAY 294 BRIDGE CROSSES THE CREEK IN THE NWSWSW SECTION 19, T8N, R11E, MEAGHER COUNTY. THE APPROPRIATOR SHALL KEEP A DAILY WRITTEN RECORD OF THE FLOW RATE MEASURED IN COTTONWOOD CREEK WHEN APPROPRIATIONS ARE OCCURING FOR THE GORDON BUTTE ENERGY PARK PROJECT. THE APPROPRIATOR SHALL DIVERT WATER ONLY DURING THE PERIOD OF APPROPRIATION WHEN THE FLOW IN COTTONWOOD CREEK AT THE MEASURING STATION EXCEEDS 16 CUBIC FEET PER SECOND. APPROPRIATOR MUST ADJUST OR CEASE ITS DIVERSION WHEN FLOWS AT THE MEASURING STATION DROP BELOW 16 CFS;

B. INSTALL A MEASURING/MONITORING DEVICE IN THE DIVERSION WORKS (71 RANCH DITCH OR CONVEYANCE FACILITY) AT THE HEADGATE IN ORDER TO MEASURE APPROPRIATIONS FROM COTTONWOOD CREEK. FOR EACH DAY OF DIVERSION UNDER THIS PERMIT, THE APPROPRIATOR SHALL KEEP A WRITTEN RECORD OF THE FLOW RATE AND VOLUME OF WATER DIVERTED AT THE HEADGATE (FOR THE GORDON BUTTE ENERGY PARK), INCLUDING THE PERIOD OF TIME OF DIVERSION. RECORDS MUST ACCOUNT SEPARATELY FOR ANY APPROPRIATIONS UNDER THIS PERMIT FROM APPROPRIATIONS UNDER ANY OTHER WATER RIGHT USING THE SAME DIVERSION WORKS/CONVEYANCE FACILITY; AND

C. THE PERMITTEE SHALL SUBMIT A PLAN INDICATING THE PROPOSED DESIGN OF EACH MEASURING OR MONITORING DEVICE AND A MAP OF THE SPECIFIC LOCATION OF EACH DEVICE. THE PLAN AND DEVICE LOCATION MUST BE APPROVED BY THE DEPARMENT BEFORE WATER IS DIVERTED UNDER THIS PERMIT. WATER MUST NOT BE DIVERTED UNTIL THE REQUIRED MEASURING/MONITORING DEVICES ARE IN PLACE AND OPERATING. RECORDS SHALL BE SUBMITTED BY JULY 30 OF EACH YEAR AND UPON REQUEST AT OTHER TIMES DURING THE YEAR. FAILURE TO SUBMIT REPORTS AS REQUIRED BY THESE CONDITIONS MAY BE CAUSE FOR REVOCATION OF THE PERMIT. THE RECORDS MUST BE SENT TO THE LEWISTOWN WATER RESOURCES REGIONAL OFFICE AT THE ADDRESS BELOW. THE APPROPRIATOR SHALL MAINTAIN THE MEASURING/MONITORING DEVICES SO THEY ALWAYS OPERATE PROPERLY AND MEASURE FLOW RATE AND VOLUME ACCURATELY DURING PERIODS OF APPROPRIATION UNDER THIS PERMIT.

2. THE APPROPRIATOR SHALL MONITOR/COORDINATE ITS APPROPRIATIONS WITH THE FOURTEENTH JUDICIAL DISTRICT COURT MUSSELSHELL RIVER DISTRIBUTION PROJECT (MRDP), WHEN THE MRDP IS ADMINISTERING WATER RIGHTS IN THE SOUTH FORK MUSSELSHELL RIVER AND THE MAINSTEM MUSSELSHELL RIVER. DURING THE PERIOD THE MRDP IS IN OPERATION, THE APPROPRIATOR SHALL ONLY DIVERT WATER WHEN ALL PRIOR WATER RIGHTS AND WATER RESERVATIONS ARE IDENTIFIED BY THE MRDP AS ENTITLED TO RECEIVE WATER IN ZONE 6 OF THE MRDP (THE ZONE THAT INCLUDES THE SOUTH FORK MUSSELSHELL RIVER). AT ANY TIME THERE IS CURTAILMENT OF WATER RIGHTS WITH A PRIORITY DATE PRIOR TO THIS PERMIT IN ZONE 6, THE APPROPRIATOR SHALL NOT DIVERT WATER. AT TIMES WHEN THE DISTRICT COURT/MRDP IS NOT ADMINISTERING WATER IN THE SOUTH FORK MUSSELSHELL RIVER, THE APPROPRIATOR MUST MONITOR STREAM GAUGES AND COMPLY WITH CERTAIN MINIMUM STREAM FLOW CONDITIONS PRIOR TO DIVERTING WATER. ALTHOUGH THE FOLLOWING CONDITIONS SPECIFY CERTAIN STREAM FLOW LEVELS AND/OR WATER RIGHT OWNERS, IT IS THE APPROPRIATOR'S RESPONSIBILITY TO ENSURE THAT ALL SENIOR WATER RIGHTS ARE BEING MET AT ALL TIMES. - 3. WHEN DIVERTING WATER PURSUANT TO PARTS 3.A.1. OR 3.A.2. OF THIS CONDITION, THE APPROPRIATOR SHALL KEEP A DAILY RECORD OF STREAM FLOWS AT USGS GAUGING STATION NO. 06119500 AND ITS DIVERTED FLOW RATE. WHEN DIVERTING WATER PURSUANT TO PART 3.A.2, APPROPRIATOR SHALL KEEP A RECORD OF THE NAME OF THE INDIVIDUAL AT THE UPPER MUSSELSHELL WATER USERS ASSOCIATION CONTACTED AND DATES FOR WHICH CONFIRMATION WAS OBTAINED THAT THE ASSOCIATION WOULD NOT BE DIVERTING WATER PURSUANT TO STATEMENT OF CLAIM NO. 40A 119518. RECORDS SHALL BE SUBMITTED BY JULY 30 OF EACH YEAR AND UPON REQUEST AT OTHER TIMES DURING THE YEAR. FAILURE TO SUBMIT RECORDS MAY BE CAUSE FOR REVOCATION OF THE AUTHORIZATION. THE APPROPRIATOR SHALL DIVERT WATER ONLY IF STATEMENT OF CLAIM NO. 40A 119686 OWNED BY THE STATE OF MONTANA, DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION, AT ITS DEADMANS BASIN STATE WATER PROJECT IS BEING MET, BASED ON DISCUSSIONS WITH AND AS DETERMINED BY THE DEADMANS BASIN WATER USERS ASSOCIATION. IT IS THE RESPONSIBILITY OF THE APPROPRIATOR TO CONTACT THE DEADMANS BASIN WATER USERS ASSOCIATION PRIOR TO DIVERTING AND AT LEAST WEEKLY THEREAFTER TO ENSURE THAT SUFFICIENT WATER IS FLOWING IN THE MUSSELSHELL RIVER TO MEET THE DEMANDS OF THE ASSOCIATION. IF THE STATE OF MONTANA'S WATER RIGHT, AS ADMINISTERED BY THE ASSOCIATION, IS NOT BEING MET, THE APPROPRIATOR SHALL CEASE DIVERSIONS.
