THIS APPROPRIATION OF WATER TAKES WATER FROM THE MILK RIVER BETWEEN FRESNO RESERVOIR AND WHITEWATER CREEK (BASIN 40J) AND USES IT IN THE MILK RIVER BETWEEN FRESNO RESERVOIR AND WHITEWATER CREEK (BASIN 40J), THE BEAVER CREEK DRAINAGE (BASIN 40M), AND THE MILK RIVER BELOW WHITEWATER CREEK DRAINAGE (BASIN 40O). ANY OBJECTION TO THIS RIGHT MAY BE FILED DURING THE OBJECTION PERIODS FOR EITHER THE POINT OF DIVERSION OR PLACE OF USE BASIN.

Remarks:

AN AMENDMENT WAS SUBMITTED ON 04/30/1982 REQUESTING TO AMEND THE POINT OF DIVERSION . THE AMENDMENT HAS NOT BEEN IMPLEMENTED AS IT HAS NOT BEEN SIGNED BY ALL OWNERS OF DNRC RECORD.

THE CLAIMED FLOW RATE EXCEEDS THE 35 GPM GUIDELINE FOR THIS PURPOSE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA.

THE CLAIMED PLACE OF USE AND ACRES IRRIGATED COULD NOT BE IDENTIFIED FROM DATA SUBMITTED WITH THE CLAIM.

THE CLAIMED VOLUME WAS NOT EXAMINED. THE CLAIMED NUMBER OF HOUSEHOLDS AND ACRES OF DOMESTIC IRRIGATION COULD NOT BE IDENTIFIED.

THE CLAIMED VOLUME EXCEEDS THE MAXIMUM FEASIBLE VOLUME. BASED ON THE FLOW RATE AND PERIOD OF USE, THE MAXIMUM VOLUME POSSIBLE IS 195.36 ACRE-FEET PER YEAR.
