DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (IF KNOWN) (Record)Set a wood post 4 ft. long by 4 ins. squar. (Found)No trace of orrigional post as area falls in lumber storage yard of the old A.C.M. lumber co. and has long been removed.

To the south I find remains of old R.R. grade and tracks which shows a distance of 277.0' from the corner on the R.R. map. To the north I find top bench where fence was undoubtedky located at time of survey at 4.00 chs.(Record fence at 4.00 chs.) At 5.00 chs. I find foot of descent. (Record foot of descent at 5.00 chs.) To the mast I find 30 ins. diam. brg. tree stump on left bank of river and drive a 2 ins. diam. pipe for location of M.C., on the right bank of river I find M.C. stone in place.

I mark the latitude for corner at the record distance of 4.00 chs. from the fence site and 5.00 chs from foot of descent to the north and 277.0 from the R.A. spur line to the south as noted on the old A.A. map.

For the departure of the corner I use the record distance of 1602.5' from the M.C. on the left bank of the river.

I set a brass cap attached to a $l_{\overline{z}}^1$ ins. diam. galv. for possition of corner and place a mound of stone around. From which a 28" yellow Pine bears NLY" 43.0' marked R.M. A 10" double lodgepole pine bears N 83° 45' N 36.8' and marked R.M.
