SUBSEQUENT RECORD: (1922 G.L.O.) From the 1/4 sec. cor. bet. secs. 33 and 34, which is a granite stone 5x8x5 ins. above ground, marked

and witnessed as described by the Surveyor General. South of the cor. and 1/2 lk. dist., set an I.D. iron post, 3 ft.

long, 1 in. diam., 30 ins. in the ground, for cor. of allotments 854 and 3253 with brass cap marked 854-3253.
