Dear Mr. Yost,

As Montana's State Names Authority, I recommend that the Domestic Names Committee approve the proposal from Review List 408 to name a rock formation in Lincoln County, Montana as "Bad Medicine Spires".

The Montana State Library released a public request for comments regarding this proposal in February of 2012. The local newspaper and a local TV station published articles about it. The proponent published a survey about names for the feature in the Western News in Libby, Montana on March 28, 2012.

This name was very controversial among the people that responded to the request for comments. Twenty-three other names for the feature were proposed or identified as being in use by the fiftyseven respondents. Please see the attached page for the complete list of names. The most commonly preferred name was "Bad Medicine," favored by twenty-one of the respondents, nineteen of whom are opposed to adding the generic term "Spires". Additionally, I found a discussion on Facebook about the name where three other people who use the name "Bad Medicine" were opposed to adding "Spires". Eighteen respondents preferred "Bad Medicine Spires" and three others found it acceptable but not preferred. Sixteen respondents preferred other names and did not indicate support or opposition to "Bad Medicine Spires".

The Lincoln County Commissioners indicated that they are not opposed to the proposal. The Forest Service's district ranger, responding to the original "Castle Cliffs" proposal for this feature, indicated that "Bad Medicine" or "Bad Medicine Spires" was preferable, and seemed to indicate that this was also the opinion her office received from the Confederated Salish and Kootenai Tribes (CSKT). I have attempted over the past 13 months to get an opinion from CSKT officials but did not receive any clear response. The responses I received seemed to indicate that they are not

opposed to the name "Bad Medicine" in general, but did not indicate whether "Bad Medicine Spires" was acceptable for this feature.

I recommend that the DNC approve the proposal because there are many names in use for the feature and these names should be recorded in the national geographic names database. Accepting this proposal is the most expedient way of accomplishing this.

While there is no requirement that a name must contain a generic part, most names of geographic features that lack a generic imply the existence of an object. There is nothing in "Bad Medicine" to indicate that the name applies to a particular feature. Some of the respondents indicated that "Bad Medicine" refers to a region rather than to the cliffs. It would be reasonable for a person unfamiliar with the area who sees "Bad Medicine" on a map to assume that the label refers to an area rather than to a specific thing.
