PURSUANT TO THE JUDGMENT FOR PERMANENT INJUNCTION FILED ON FEBRUARY 22, 1971, IN CAUSE NO. 4365 IN THE DISTRICT COURT OF THE THIRD JUDICIAL DISTRICT, GRANITE COUNTY, THE TOWN OF PHILIPSBURG, ITS EMPLOYEES, SERVANTS AND AGENTS ARE PERPETUALLY ENJOINED AND RESTRAINED FROM INTERFERENCE WITH THE WATER RIGHTS OF OLLIE GWYNN, WATER RIGHT NOS. 76GJ-120550-00 THROUGH 76GJ-120561-00, INCLUSIVE, AND HER SUCCESSORS, AND THE TOWN OF PHILIPSBURG IS FURTHER DIRECTED THAT DURING THE PERIOD FROM JULY 25 TO SEPTEMBER 30 OF EACH YEAR, THE TOWN OF PHILIPSBURG SHALL RELEASE NOT TO EXCEED 2.325 CFS (93.00 MINERS INCHES) FROM THE SURPLUS IMPOUNDED NATURAL FLOW OF FRED BURR CREEK FROM ITS DAMS.

STARTING IN 2008, PERIOD OF DIVERSION WAS ADDED TO MOST CLAIM ABSTRACTS, INCLUDING THIS ONE.

IMPLIED CLAIM NO. 76GJ 210974-00 WAS AUTHORIZED AND GENERATED BASED ON INFORMATION IN THIS CLAIM.

WHENEVER WATER RIGHTS 76GJ 148497-00 AND 76GJ 148506-00 ARE COMBINED TO SUPPLY WATER FOR MUNICIPAL USE, THE TOTAL COMBINED FLOW RATE FOR THE RIGHTS SHALL NOT EXCEED 2.00 CFS.

WHENEVER THE FOLLOWING WATER RIGHTS ARE COMBINED TO SUPPLY WATER FOR MUNICIPAL USE THE TOTAL COMBINED FLOW RATE FOR THE FOLLOWING RIGHTS SHALL NOT EXCEED 5.00 CFS FROM OCTOBER 1 THROUGH APRIL 30 AND SHALL NOT EXCEED 7.00 CFS FROM MAY 1 THROUGH SEPTEMBER 30 AND THE SUM TOTAL VOLUME OF THE COMBINED USE SHALL NOT EXCEED 1999.00 ACRE-Feet PER YEAR. 76GJ 148497-00, 76GJ 148506-00, 76GJ 148511-00, 76GJ 210974-00, 76GJ 210976-00.
