BIG HORN COUNTY RECORDS AS OF 02/11/2009 SHOWS PLACE OF USE IS OWNED BY USA IN TRUST FOR CROW TRIBE.

THE CLAIMED PRIORITY DATE PRECEDES 7/25/1868 , THE EARLIEST GENERAL DATE OF SETTLEMENT WITHIN THE DRAINAGE.

AT THE TIME OF THE CLAIMED PRIORITY DATE, IT APPEARS THAT THE PLACE OF USE WAS PART OF AN INDIAN RESERVATION.
