THE APPROPRIATOR SHALL PAY HIS PROPORTIONATE SHARE OF THE FEES, COMPENSATION AND EXPENSES, AS FIXED BY THE DISTRICT COURT, INCURRED IN THE DISTRIBUTION OF THE WATERS.

A SECONDARY POINT OF DIVERSION LOCATED IN THE NWSESW OF SEC 34, TWP 3S, RGE 9W, BEAVERHEAD COUNTY WAS ADDED TO THIS WATER RIGHT BY CHANGE NO. 19430900-41D. THE APPROPRIATOR SHALL DIVERT NO MORE THAN 3.87 CFS (154.66 MINERS INCHES) FROM ROCK CREEK UNDER WATER RIGHT NO. 194309, LEAVING .13 CFS (5 MINERS INCHES) TO BE USED BY THE TADOVICH-JENSEN DITCH USERS FOR CARRIAGE LOSS.

THE ACRES OF THIS RIGHT HAVE BEEN REDUCED BY 16.00 ACRES. THE 16.00 ACRES IN THE S2NE, SEC 4, TWP 4S, RGE 9W, BELONG TO GREG FELDER WHO DID NOT RECEIVE A PORTION OF THIS RIGHT.
