THE JUNE 9, 1987 STIPULATION FILED BY THE PARTIES SPECIFIES: "PROVIDED THAT WHEN THE WATERS HEREIN ALLOCATED SHALL BE USED FROM THE POINT OF DIVERSION IN PARKER CREEK DESIGNATED AS NW 1/4 NE 1/4 NW 1/4 SECTION 13, T4S, R2W, M.P.M. PRIORITY OF THIS CLAIM AT THIS POINT SHALL BE DEEMED JUNIOR TO THE WATER RIGHTS CLAIMED UNDER CLAIMS NUMBERED 41F-W- 136397 AND 41F-W-136398."

THIS RIGHT IS THE PARENT CLAIM OF CLAIMS 41F 30071250 THROUGH 30071338. THE WATER RIGHT REPRESENTED BY THE PARENT CLAIM WAS HISTORICALLY USED TO IRRIGATE A TOTAL OF 1119 ACRES WITHIN A SINGLE RANCH. THE PLACE OF USE WAS SUBSEQUENTLY SUBDIVIDED INTO 90 INDIVIDUAL LOTS. THE WATER RIGHT WAS HISTORICALLY ROTATED THROUGHOUT THE PLACE OF USE AT THE DISCRETION OF THE LAND OWNER.

STARTING IN 2008, PERIOD OF DIVERSION WAS ADDED TO MOST CLAIM ABSTRACTS, INCLUDING THIS ONE.
