THIS CHANGE SHALL NOT BE EXERCISED UNTIL THE REQUIRED MEASURING DEVICE IS IN PLACE AND OPERATING. IF MORE THAN ONE POINT OF DIVERSION IS USED, APPROPRIATOR SHALL INSTALL DEPARTMENT APPROVED MEASURING DEVICES ON THE LOWERMOST POINT OF DIVERSION AND THE UPPERMOST POINT OF DIVERSION. ON A FORM PROVIDED BY THE DEPARTMENT, THE APPROPRIATOR SHALL KEEP A WRITTEN WEEKLY RECORD OF THE VOLUME OF MITIGATION WATER NOT DIVERTED AND LEFT INSTREAM, INCLUDING THE PERIOD OF TIME. RECORDS SHALL BE SUBMITTED BY NOVEMBER 30 OF EACH YEAR AND UPON REQUEST BY THE DEPARTMENT AT OTHER TIMES DURING THE YEAR. FAILURE TO SUBMIT RECORDS MAY BE CAUSE FOR REVOCATION OF A
